



Georgia Intrastate Motor Carrier (GIMC) Step by Step Registration Application Instructions

Please follow instructions below to complete the GIMC Registration Application Process.

B. Under the Heading: GIMC Registration

Click on

1. Choose Option 1: To apply for your GIMC Registration online, click [here](#)
2. Choose Option 2: To renew existing Registration click [here](#)
3. You will need the USDOT number
4. You will need the VIN number for all vehicles that are 10,001 lbs. (power unit by itself or the power unit with the combination of a trailer)
5. Select year to register
6. Complete the application until you can pay
7. Choose Pay Now
8. Pay with Credit or Debit Card
9. Fee is \$5.00 per vehicle before or by current year registration deadline (i.e. 12/31/18) or new USDOT number for current year registration (i.e. 2019)
10. Late fee is \$25.00 per vehicle after current year registration deadline (i.e. 12/31/18) or operated in past year (i.e. 2018)

Note: Based on when you obtained your USDOT number you are liable to register and pay the fee due for the past and current year registrations

11. Choose Pay Later
12. Mail in a Certified Check or Money Order only for exact amount due (no personal or business checks accepted)

1. GIMC Affidavit
2. Print the first page
3. Get Notarized
4. Make front and back copy of valid Driver License or passport of the person who signed the GIMC Affidavit for proof of citizenship
